Joint Public Notice

U.S. Army Corps of Engineers and State of Arkansas

AUTHORITY: Pursuant to 33 CFR 325, as published in the Federal Register dated November 13, 1986, this notice announces an application submitted for an after-the-fact Department of the Army permit under Section 404 of the Clean Water Act.

PURPOSE: According to the applicant, the project purpose is to enhance the area by increasing the existing lake size as well as provide shallow water areas and create a meandering ditch at the project site.

LOCATION: The project site is located in Section 8, Township 11N, Range 10E, in Mississippi County, Arkansas, at approximate Latitude 35.58419° and Longitude -90.04596° on the Wilson 7.5 minute USGS quadrangle map (Attachment 1).

DESCRIPTION OF WORK: As part of the lake expansion and habitat creation, the applicant has impacted 2,100 linear feet of Ditch No. 26. Approximately 560 linear feet of fill has been placed in Ditch No. 26. Approximately 430 linear feet of Ditch No. 26 has been converted into deep water habitat for the lake. The remaining approximately 1,100 linear feet of Ditch No. 26 has been altered so that it will no longer function as a flowing ditch. The existing lake will be expanded to the north and east of Ditch No. 26 by removing an existing road/levee (Attachment 2).

AVOIDANCE/MINIMIZATION: According to the applicant, Ditch No. 26 was only filled in the areas required to complete the project.

MITIGATION: The applicant proposes to mitigate impacts to Ditch No. 26 with the newly created approximately 2,020 linear foot meandering ditch. The applicant also proposes to mitigate impacts with the created 14.79 acre shallow water area. This shallow water area has been planted in native grasses such as Indian Grass and Big Bluestem Grass. Native grasses have also been planted to the north and east of the proposed lake expansion (Attachment 2).

WATER QUALITY CERTIFICATION: By copy of this public notice, the applicant is requesting water quality certification from the Arkansas Department of Environmental Quality that the activity will comply with applicable requirements set forth in 33 U.S.C. and 1341 (a)(1) of the Clean Water Act and all state laws and

regulations promulgated pursuant thereto. This certification or evidence of the water quality certification or waiver of the right to certify must be submitted prior to the issuance of a Corps of Engineers permit. The Corps of Engineers evaluation of the impact of the activity on the public interest will include application of the guidelines promulgated by the Administrator, EPA, under authority of Section 404(b) of the Clean Water Act.

ENDANGERED SPECIES: Our preliminary determination is that there would be no endangered species or critical habitat affected by this proposal. However, this notice is being coordinated with the U.S. Fish and Wildlife Service (USFWS). Any comments USFWS may have regarding endangered or threatened wildlife or plants, or their critical habitat, will be considered in our evaluation of the described work.

CULTURAL RESOURCES: A review of the National Register of Historic Places indicated no known resources within the project area. However, the Memphis District will evaluate information provided by the State Historic Preservation Officer, federally recognized Tribes, and the public in response to this public notice and we may require a survey of the project area.

FLOODPLAIN: In accordance with 44 CFR Part 60 (Floodplain Management and Use), participating communities are required to review all proposed development to determine if a floodplain development permit is required. Floodplain administrators should review the proposed public notice and notify this office of any floodplain development permit requirements.

PUBLIC INTEREST REVIEW: The purpose of this public notice is to advise all interested parties of the activities for which a permit is sought and to solicit comments and information necessary to evaluate the probable impact on the public interest.

The decision whether to issue a permit will be based on an evaluation of the probable impact including cumulative impacts of the activity on the public interest. That decision will reflect the national concern for both protection and utilization of important resources. The benefits, which reasonably may be expected to accrue from the project, must be balanced against its reasonably foreseeable detriments. All factors which may be relevant to the project will be considered, including the cumulative effects thereof; among those are conservation, economics, aesthetics, general environmental concerns, wetlands, historic properties, fish and wildlife values, flood hazards, floodplain values, land use, navigation, shoreline erosion and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs, considerations of property ownership and in general, the needs and welfare of the people.

The Corps of Engineers is soliciting comments from the public; federal, state and local agencies and officials; federally recognized Tribes; and other interested parties in order to consider and evaluate the impacts of this proposed activity. Any comments received will be considered by the Corps of Engineers to determine whether to issue, modify, condition or deny a permit for this proposal. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects and the other public interest factors listed above. Comments are used in the preparation of an Environmental Assessment and/or an Environmental Impact Statement pursuant to the National Environmental Policy Act. Comments are also used to determine the need for a public hearing and to determine the overall public interest of the proposed activity.

PUBLIC HEARING: Any person may request, in writing, within the comment period specified in this notice that a public hearing be held to consider this application. Requests for a public hearing shall state, with particularity, the reason for holding a public hearing. The District Engineer will determine if the issues raised are substantial and whether a hearing is needed for making a decision. If a public hearing is held, it will be for the purpose of obtaining additional information that we could not otherwise obtain through a public notice process; not to inform the public about the specific details of the project in greater detail than what is found in this notice.

This is not a Corps of Engineers project. We are not a proponent nor are we an opponent of the project. We are merely the permitting authority of Section 404 and Section 10 permits required by our office.

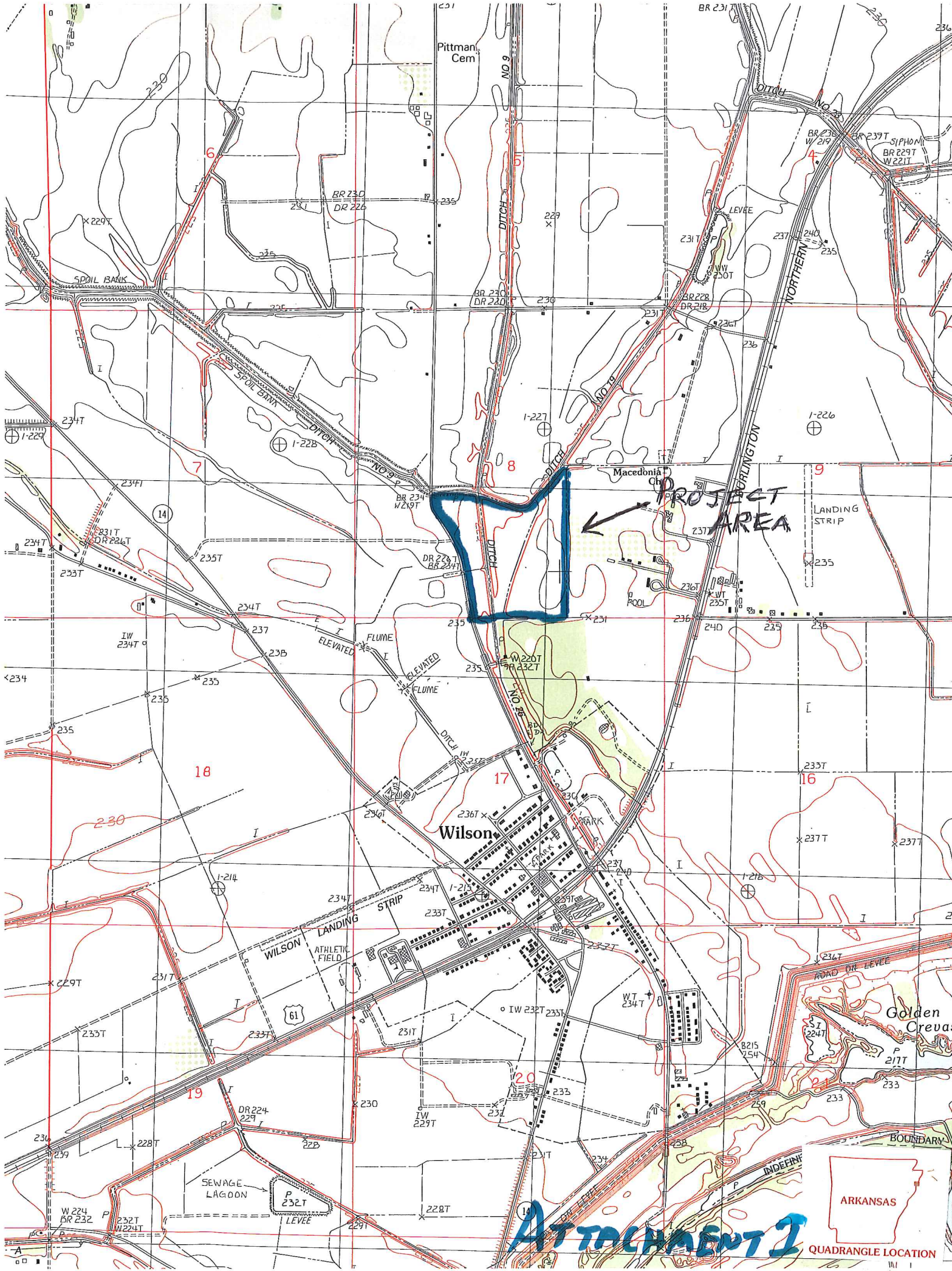
