OPTIONAL ADDITIONAL INFORMATION SUPPORTING NJD (e.g., discussion may include information reviewed to assess potential navigation or interstate commerce connections - 1 to 3 paragraphs): Less than 0.2 acre of wetland is present in a small wooded area south of an existing railroad line. This wetland area includes an abandoned farm pond that now exhibits wetland characteristics as well as some scattered wetland depressions surrounding the pond. No distinct hydrological connection was observed between the wetlands and any downstream waters. Migratory songbirds (indigo buntings and common yellowthroats) were heard in nearby wooded areas; it is possible that these birds could utilize this area.
