C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The predominant land use in the project area involves large scale, intensive agricultural production. Agricultural management includes disking, tilling, plowing, harvesting, and other farm related soil disturbance activities that unconsolidate sediments and increase mobilization. Agricultural activities also include the use of fertilizers, herbicides, pesticides, and various other soil and plant treatments to improve crop yields and control animal and plant pests. These activities generate pollutants that are mobilized by rain, irrigation events, wind, or other erosion factors. The RPW contains vegetation at segments that provide a hydraulic roughness that slows runoff waters and allows sediment and pollutants to precipitate out of solution and be absorbed by soils or uptaken by vegetation and/or transformed by microbes and fungi. The RPW also has buffers along both sides to attenuate and absorb runoff, nutrients, and filter the water before it enters the RPW. Bayou DeView, a downstream receiving water, is on the 303(d) list for impaired waters. Aquatic species use the RPW as habitat during parts of or all of their lifecycles. The RPW is used for foraging, nesting, spawning, shelter, raising young, or as corridors for these activities. The RPW provides a corridor for aquatic species to immigrate or emigrate, habitat for lifecycles, and provide nutrients and organic carbon to downstream food webs, thus providing a biological connection.
