Responsibilities/Duties:

Uses conventional machine tools and Computer Numerical Controlled (CNC) machine tools to manufacture parts, and complete items of equipment from raw stock.

Typically performs the following:

1. Lays out work from blueprints, drawings and sketches, work orders, model of parts to be made or other specifications. Applies shop mathematics and handbook formulas to compute and establish dimensions for planning and laying out the work.

2. Programs, sets up and operates CNC lathes, mills, machining centers, and engravers.

3. Performs maintenance on shop tools and equipment, sharpens drill bits, turning tools, and forming tools.

4. Diagnoses and repairs malfunctioning flood control lift gate mechanisms, geared winches, and other mechanical equipment in the field and in the shop.

5. Operates motor vehicles including pickup trucks towing trailers to transport personnel, materials, and supplies. Operates forklifts, aerial boom lifts, and scissor lifts.

Performs other duties as assigned.

Conditions of Employment & Notes:

- Incumbent is required to sign a DA Form 5019-R, "Condition of Employment for Certain Civilian Positions Identified as Critical Under the Drug Abuse Testing Program," or a Memorandum of Understanding.
- This position is subject to a pre-employment drug test screening, and random testing thereafter.
- This position requires the completion of a pre-employment and annual physical examination to ensure required level of physical health and ability or fitness to perform the duties of the position.

- Must successfully pass pre-employment manual machinist skills test. Must obtain and/or maintain a valid state driver's license.
- Must obtain the following within 1 year of employment and/or maintain thereafter:
 - Forklift operator's license
 - Overhead gantry crane operator's license
 - Scissor lift operator's license
 - Aerial boom lift operator's license
