MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ MVM-2024-025 MFR 1 of 1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

3. REVIEW AREA. The review area consists of an approximately 30-acre parcel located in Section 35, Township 14N, Range 4E, in Craighead County, Arkansas, at approximate coordinates 35.8011°N, -90.6397°W.
4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The nearest TNW is the St. Francis River.⁶

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS. Wetland A flows to an unnamed tributary, then to Whiteman Creek, then to Little Bay Ditch, then to Ditch No. 9, then to Ditch No. 10, then to Straight Slough, then to St. Francis Bay, then to St. Francis River. Wetland B is surrounded by uplands but could flow by infrequent overland flow or another method to an unnamed tributary, then to Whiteman Creek, then to Little Bay Ditch, then to Ditch No. 9, then to Ditch No. 10, then to Straight Slough, then to St. Francis Bay, then to St. Francis River. There is no physical connection between Wetland B and the St. Francis River.

resource or feature, and how it was determined to be an “isolated water” in accordance with SWANCC. N/A

- f. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the pre-2015 regulatory regime consistent with the Supreme Court’s decision in *Sackett* (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

Wetland A, (35.8027, -90.6382), is approximately 0.2-acres. Wetland A directly abuts a Non-Relatively Permanent Water (Non-RPW) and flows for approximately 1,500 linear feet before entering a Relatively Permanent Water (RPW). Consistent with the EPA memo dated 12 March 2025, the wetland does not have a continuous surface connection to an RPW and is therefore not adjacent.

Wetland B, (35.8011, -90.6410), is approximately 0.8-acres. The wetland is surrounded by an upland field on all sides. Wetland B does not have a continuous surface connection by directly abutting an RPW and, consistent with the EPA memo dated 12 March 2025, is not adjacent.
