MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), 1 MVM-2023-230 (MFR 1 of 1)

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA), the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Tennessee due to litigation.

1. SUMMARY OF CONCLUSIONS.

- 3. REVIEW AREA. The review area covers approximately 26 acres located in three subsections of the Fletcher Creek sewer basin within the City of Memphis, Shelby

County, Tennessee. Section 1 is located along Rockcreek Parkway and Lake Edge Drive. Section 2 is located between Chimneyrock Boulevard and Dexter Road, east of Germantown Parkway. Section 3 is the existing sewer crossing under I-40 southwest of Whitten Road.

- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The project area drains to the Wolf River.

EPH-1 (160 linear feet) is a non-relatively permanent water channel that originates from a stormwater culvert that only contains water in direct response to precipitation that primarily drains upland residential areas.

EPH-2 (190 linear feet) is a non-relatively permanent water channel that originates from a stormwater culvert that only contains water in direct response to precipitation that drains upland residential areas.

EPH-3 (52 linear feet) is a non-relatively permanent water channel that originates from a stormwater culvert that only contains water in direct response to precipitation that drains upland residential areas.

EPH-4 (250 linear feet) is a non-relatively permanent drainage channel that originates from a roadside drainage ditch that only contains water in direct response to precipitation that drains upland residential areas.

EPH-5 (125 linear feet) is a non-relatively permanent water channel that only contains water in direct response to precipitation that primarily drains the surrounding uplands and runoff from I-40.

WTL-2 (0.05-acre) is a depressional wetland along Germantown Parkway. WTL-2 has no continuous surface connections to other waters and does not directly abut a relatively permanent water.

WTL-3 (0.22-acre) is a depressional wetland south of I-40. WTL-3 has no continuous surface connections to other waters and does not directly abut a relatively permanent water.
