MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ MVM-2025-287 MFR 1 of 1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

categories of waters of the United States under the pre-2015 regulatory regime consistent with the Supreme Court's decision in *Sackett* (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

Wetland 1, (35.18143, -90.189067), is approximately 0.02-acres. The wetland is surrounded by uplands on all sides. Wetland 1 does not directly abut a Relatively Permanent Water (RPW). Consistent with the EPA memo dated 12 March 2025, the wetland does not have a continuous surface connection to a RPW and is therefore not adjacent.

Wetland 2, (35.181609, -90.188420), is approximately 0.13-acres. The wetland is surrounded by uplands on all sides. Wetland 2 does not directly abut a Relatively Permanent Water (RPW). Consistent with the EPA memo dated 12 March 2025, the wetland does not have a continuous surface connection to a RPW and is therefore not adjacent.

Wetland 3, (35.180437, -90.189485), is approximately 0.01-acres. The wetland is surrounded by uplands on all sides. Wetland 3 does not directly abut a Relatively Permanent Water (RPW). Consistent with the EPA memo dated 12 March 2025, the wetland does not have a continuous surface connection to a RPW and is therefore not adjacent.

Wetland 4, (35.179744, -90.189939), is approximately 0.06-acres. The wetland extends beneath the railroad track and connects to a drainage feature. The drainage feature terminates without a defined outlet or receiving body. Wetland 4 does not directly abut a Relatively Permanent Water (RPW). Consistent with the EPA memo dated 12 March 2025, the wetland does not have a continuous surface connection to a RPW and is therefore not adjacent.
