MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ MVM-2025-146 (MFR 1 of 1)

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable Arkansas due to litigation.

1. SUMMARY OF CONCLUSIONS.

3. REVIEW AREA. The review area covers 73.03 acres within a tract of land located at 2290 S. Washington Street, Forrest City, St. Francis County, Arkansas. Approximate coordinates of the site are 34.984129°N, -90.786560°W.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The project are drains towards the St. Francis River.

FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS The entire project area drains through an unnamed tributary to the south and west into Hinton Creek, then into Coffee Creek, then into the L'Anguille River, the lower end of which is a TNW. Specifically, Drainage 1, Ditch 1, Ditch 3, Ditch 4, Ditch 5, and Ditch 6 all drain southeast into Ditch 2, which drains into the same unnamed tributary that runs off site at the southwest portion of the project area.

Drainage 1 (810 linear feet) is an upland swale that lacks indicators of an ordinary high water mark. It originates in an agricultural field and drains field runoff south towards Ditch 1.

Ditch 1, Ditch 2, Ditch 3, Ditch 4 are manmade ditches dug in an upland agricultural field for the purpose of draining the field and all lack indicators of an ordinary high water mark.

Ditch 5 is a non-relatively permanent water channel that only contains water in direct response to local precipitation. This feature primarily drains the surrounding upland agricultural fields and lacks indicators of an ordinary high water mark.

Ditch 6 is a roadside ditch that lacks indicators of an ordinary high water mark and only carries stormwater (non-relatively permanent) flow.
