MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ MVM-2024-026

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Tennessee due to litigation.

- REVIEW AREA. The review area covers approximately 119-acres located south of Summers Road, west of Airline Road, and north of Interstate 40 in Arlington, Shelby County, Tennessee. Approximate coordinates of the site are 35.26362°N, -89.67032°W.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The project area drains to the Mississippi River.

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS.

Channel 1 (248 LF), Channel 2 (1595 LF), Channel 3 (670 LF), and Channel 5 (380 LF) are upland drainage ditches that all flow into Hall Creek, which then flows into Cypress Creek, then to the Loosahatchie River, then into the Mississippi River. Channel 4 is an upland drainage ditch that flows into Southeast Stream (Southeast Stream is addressed under a preliminary jurisdictional determination) which flows into Hall Creek, then to Cypress Creek, then the Loosahatchie River, then into the Mississippi River.

The sediment basin located on site is a 1.43-acre sediment basin, created and located in an upland area on the project site. The sediment basin falls under the definition of a preamble water and therefore is considered non-jurisdictional.

Channel 1 (248 LF), Channel 2 (1595 LF), Channel 3 (670 LF), and Channel 5 (380 LF) are upland drainage ditches that all flow into Hall Creek (Hall Creek is addressed under a preliminary jurisdictional determination). Channels 1, 2, 3, and 5 do not carry relatively permanent flow and all lack indicators of an ordinary high-water mark. Channel 4 (624 LF) is an upland drainage ditch that flows into Southeast Stream. (Southeast Stream is addressed under a preliminary jurisdictional determination). Channel 4 does not carry relatively a permanent flow and lack indicators of an ordinary high-water mark.
