MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), 1 MVM-2022-296 MFR 1 of 2.2

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

- 3. REVIEW AREA. The review area is an approximately 91.43-acre property located along the north side of Highway 72 in Walnut, Tippah County, Mississippi. Latitude 34.953713, Longitude -88.922604. Attached is a map with the boundary of the review area. No previous AJD's have been completed for the review area.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. Muddy Creek is an interstate water, and the Hatchie River is a TNW

isolated pond, (P-1) and one erosional feature (S-1) located in the project area that do not contain a flow path as they are isolated and do not contain a continuous surface connection to any other waters. There is also a manmade upland drainage feature (W-5) that flows under U.S. Highway 72 and into an unnamed tributary which then flows into Big Creek which flows into Muddy Creek, then to an unnamed tributary which flows into the Hatchie River.

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

a. Describe aquatic resources and other features within the review area identified as "generally non-jurisdictional" in the preamble to the 1986 regulations (referred to as "preamble waters"). The pond located on the site, (P-1), is a 0.06-acre stock watering pond, created and located in an upland area on the project site. (P-1) does not contain a surface or sub-surface connection to any other waters. (P-1) falls under the definition of a preamble water and therefore is considered non-jurisdictional.

b. Describe aquatic resources and features within the review area identified as "generally not jurisdictional" in the *Rapanos* guidance. Include size of the aquatic resource or feature within the review area and describe how it was determined to be non-jurisdictional under the CWA based on the criteria listed in the guidance.

Erosional swale (S-1) is an approximately 250-linear foot swale that originates from upland run-off due to tree clearing in the subject property and does not connect to downstream channels. This feature lacks continuous indicators of an ordinary high-water mark, and no hydric soils were detected. This feature also lacked flowing water and is not a relatively permanent water; therefore, it would not be considered jurisdictional.

- c. Describe aquatic resources and features identified within the review area as waste treatment systems, including treatment ponds or lagoons designed to meet the requirements of CWA. - 2.b.). Include the size of the aquatic resource or feature within the review area and describe how it was determined to be prior converted cropland. N/A
- e. Describe aquatic resources (i.e. lakes and ponds) within the review area, which do not have a nexus to interstate or foreign commerce, and prior to the January 2001 Supreme Court decision in "SWANCC," would have been jurisdictional based solely on the "Migratory Bird Rule." Drainage feature (W-5) is a man-made, 0.44-acre upland drainage ditch that was constructed in uplands and is not a relatively permanent water. This feature was observed with a lack of flowing water and did not contain hydric soils.
