B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: There is a man-made basin just east of the subject property that has historically leaked onto the property. This leak has been repaired and field site visits have verified that the potential for wetland hydrology has been removed.
