### Lindsey,

It has been brought to my attention that the local news is reporting that construction of this project may start in June. Please remember from the last meeting we had, it was discussed that any fill placed on the park will require an in depth slope stability design which we believe will be challenging. Please let all involved know the timeline and construction for this proposed work is dependent on getting the proper permits. Tom Lee Park is owned by the City of Memphis and they are step 1 in the approval process but it is also a federal project and requires Section 408 permissions/ Regulatory permits from USACE prior to any work being started. As discussed in our previous meeting, it must be proven that there will be no adverse effect to the stabilization project in order to grant 408 permission. Should this stabilization project fail, navigation will be seriously impeded.
