Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: There are approximately 0.09-acre of isolated wetland within the limits of a proposed road alignment. The approximate 15.2-acre road alignment is located immediately east of the intersection of Inglewood Place and Donelson Road and west of Donelson Farms Parkway in Arlington, Shelby County, Tennessee, as shown on the attached USGS location map. The wetland delineation was conducted by a consultant on October 30, 2013 and wetland boundaries

were verified by the Corps on December 31, 2013. The wetland boundaries, as surveyed with the use of a GPS unit (Trimble GeoXT), are outlined with blue cross-hatch on the attached aerial map. The eastern-most isolated wetlands are located within an area previously graded during construction of the adjacent elementary school. The western-most wetland is located within a small isolated depression which was likely constructed in the past for use as a livestock pond. The wetlands have no apparent surface (or shallow subsurface) water connections to downstream waters. The NRCS Shelby County soil survey indicates that the wetlands have formed within either Gullied land (Gs), Loring silt loam (LoB2), and Grenada (GaD) soils. Neither of these soil classifications is listed as hydric in Shelby County by the NRCS. As shown on the FEMA Flood Insurance Rate Map (Map ID 47157C0220G), the wetland areas in question are not within a flood hazard zone. The subject wetlands are not adjacent to a TNW as they are approximately 32 river miles from the nearest TNW (Mississippi River) as shown on the attached USGS map. Representative photos as provided by the consultant are attached.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Four wetlands were identified on the site within areas previously graded during construction activities and within an abandoned livestock pond. Site visits revealed that no surface drainage patterns are present. The wetlands are located within well-defined depressions and the location of the wetlands is not mapped within a designated floodplain. Therefore, the wetlands are considered isolated and non-regulated.
