- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There are approximately 1.64 acre of isolated wetland on the subject boundary. The approximate 20-acre property is located immediately south of Raleigh LaGrange Road and west of Whitten Road in Memphis, Shelby County, Tennessee as shown on the attached USGS location map. The wetland delineation was performed by a consultant on September 17, 2013 and wetland boundaries were field verified by the Corps on September 23, 2013. The

approximate wetland boundaries are shown as outlined on the attached map. The isolated wetlands are located within trapped depressions and have no apparent surface (or shallow subsurface) water connections to downstream waters. The subject property has previously been cleared, graded and is regularly maintained by mowing. The regular mowing of the site appears to have contributed to the formation of the wetland depressions. The NRCS Shelby County soil survey indicates that the wetlands have formed within Falaya soils (partially hydric). As shown on the FEMA Flood Insurance Rate Map (Map ID 47157C0312G), the wetlands mapped on the property are not within a flood hazard zone. Representative photos as provided by the consultant are attached.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Approximately 1.64-acre of herbaceous wetlands were identified on the site within a site previously disturbed with grading and mowing activities. Site visits revealed that no surface drainage patterns are present. The wetlands are located within a well-defined depression and the site is not mapped within a designated flood hazard zone. Therefore, the wetlands are considered isolated and non-regulated.
