C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Ditches 9 and 10 possess features of seasonal RPWs with ordinary high water marks (OHWM) and defined bed and banks. Ditch 9 has an average width of 24 feet at the OHWM and Ditch 10 has an average width of 12 feet at the OHWM. Ditch 10 flows into Ditch 9, which flows into Ditch 40, which flows into the Tyronza River, which is a Traditional Navigable Water (TNW). The total drainage area for Ditches 9 and 10 in our review area is approximately 4, 246 acres. This area is dominated by agricultural fields within the relevant reach. Ditches 9 and 10 have a high potential to convey sediments, attached nutrients, and

contaminants to downstream receiving waters. Wetlands abutting ditch and filter pollutants.

Ditch 9 have the capability to intercept run-off before entering the
