B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Wetlands serve as habitat for mammals, birds, reptiles, amphibians, and insects. Wetlands are made up of bottomland hardwoods. Wetlands serve to reduce erosion, uptake runoff from agricultural fields, including sediment, herbicides, pesticides, and chemical fertilizers. Wetlands may also attenuate flood waters and recharge the aquafier.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Bottomland Hardwood wetlands are known to absorb sediments and nutrients. The wetland in question lies between agricultural land and the RPW, allowing the bottomland hardwood wetland to absorb runoff, nutrients, and filter the water before it enters the RPW and providing a chemical connection. Wattensaw Bayou, a downstream receiving water, is on the 303(d) list for impaired waters due to dissolved oxygen levels. The subject bottomland hardwood has a direct physical connection to the RPW either from precipitation events or surface inflow from the agricultural runoff; water was observed flowing from the wetland to the abutting RPW. Additionally, bottomland hardwood wetlands serve to attenuate flood waters. Bottomland hardwood wetlands are known to support many aquatic fauna. Many of the fauna utilize RPW's during periods when the bottomland hardwood wetlands have only subsurface water or during certain life cycle events. The RPW also provides a corridor for aquatic species to immigrate or emigrate, and provides nutrients and organic carbon to downstream food web, thus providing a biological connection.
