Explain: **There is approximately 0.29-acre of isolated wetland on the subject boundary. The 23.37-acre property is located at 9540 Poplar Avenue in Germantown, Shelby County, Tennessee, as shown on the attached USGS location map. The wetland delineation was conducted by BDY Environmental, LLC on May 4, 2016 and provided in a report dated June 23, 2016. Wetland boundaries were verified by the Corps in the field on July 5, 2017. The delineated**

wetland boundary is outlined and labeled "Wetland 1" on the attached map. The isolated wetland is located within active pasture and confined to a shallow depression with no apparent surface (or shallow subsurface) water connections to downstream waters. There is a storm water inlet in the vicinity of the wetland near the southeast corner of the property. Indicators of a surficial connection (i.e. matted vegetation, drainage patterns, etc.) from the isolated wetland to the inlet were not present during the field review. As shown on the FEMA Flood Insurance Rate Map (Map Number 47157C0490G, revised February 6, 2013), the area in question is not within a flood hazard zone. In addition, aerial photography (dated 2015), USGS Germantown and Collierville Quadrangle Maps, NRCS Soil Maps for Shelby County, Tennessee, USGS National Hydrologic Dataset (NHD) Map, U.S. Fish and Wildlife National Wetland Inventory (NWI) database were reviewed concluding the feature identified by BDY Environmental, LLC as Wetland-1 is isolated, and not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a). Representative photos provided by BDY Environmental, LLC are attached.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The 0.29-acre wetland was identified on the site within active pasture. Required wetland criteria established in the 1987 Wetland Delineation Manual including the Regional Supplement are present. Site visits revealed that no apparent surface (or shallow subsurface) drainage patterns are present. The wetland is located within a confined depression and the site is not mapped within a designated floodplain. Therefore, the wetland is considered isolated and non-regulated.
