Explain: **There is approximately 30.3 acres of isolated wetland within the subject boundary. The subject site is located at 2923 CR 402 in Corinth, Alcorn County, Mississippi as shown on the attached USGS location map. The wetland delineation was conducted by Herring Environmental, LLC on 12 October 2017 and 19 October 2017 and provided in a report dated 14 November 2017. Wetland boundaries were verified by the Corps in the field on 19 October 2017. The**

delineated wetland is outlined and labeled "Wetland W2" on the attached map. The isolated wetland is located within upland habitat and confined to a shallow basin with no apparent surface (or shallow subsurface) water connections to down stream waters. As shown on the FEMA Flood insurance Rate Map (#28003C0069C dated 17 July 2009) the area in question is not within a flood hazard zone. In addition, aerial photography (1997, 2004, 2006, 2007, 2010, 2012 and 2015), USGS Corinth Quadrangle Maps, NRCS Soils maps for Alcorn County, MS, Lidar Maps and US Fish and Wildlife Service NWI database were reviewed. We have concluded the feature identified by Herring Environmental, LLC as Wetland W2 is isolated, and not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 30.3 acre wetland is located on a site surrounded by uplands. Required wetland criteria established in the 1987 Wetland Delineation Manual and the Regional Supplement are present. Site visits revealed that no apparent surface (or shallow subsurface) drainage patterns are present. The wetland is located within a confined depression and the site is not mapped within a designated flood plain. Therefore, the wetland is considered isolated and non-regulated.
