### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Delineation Manual and accompanying Regional supplement. The delineation was performed by Allen Engineering and Science and the results were provided in a report, dated March 2, 2020. The consultant's report indicates that one of the wetland areas was observed adjacent to an existing farm pond, and the second area was observed within a historically drained farm pond that had a breached dam. Neither wetland area had an apparent surface or shallow subsurface hydrological connection to any of the observed jurisdictional features (downstream waters) during the consultant's multiple site visits in 2016 and more recently in January of 2020. No defined channel with an ordinary high water mark (OHWM) was present. As shown on the attached FEMA flood insurance map (Existing Conditions Map), the areas are not located in a flood hazard zone. Review of the attached NRCS Marshall County soils map indicates the areas occur in Loring and Grenada soil series. Neither of these series are listed on the County list of hydric soils by NRCS. The attached NWI map does not indicate any previously occurring wetlands on the property. Based on a review of the consultant's determination, the Corps concurs that the two wetland areas associated with the two farm ponds on the property, totaling 1.79 acres, are hydrologically isolated and, therefore, not jurisdictional under Section 404 of the Clean Water Act as defined in 33 CFR Part 328.3(a).**

### C. SIGNIFICANT NEXUS DETERMINATION
