The drainage feature does not have a discernible plane of ordinary high water and no indicators of seasonal flow are present. The ditch has flow only in direct response to rain events and is ephemeral in nature.		
ESTR2	747	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	The feature is the upper end of an intermittent stream determined to be potentially jurisdictional by a previous preliminary jurisdictional determination. Beginning at coordinates N35.00135/W89.95123 and moving upstream (south) of that point, the intermittent streams transitions to an ephemeral channel. Upstream of the coordinates, the stream loses seasonal flow indicators as well as a plane of ordinary high water.
