The subject wetland is physically separated from (a)(1) – (a)(3) waters by an artificial berm that does not allow for a direct hydrologic connection between the wetlands and the waters in a typical year. The applicant provided a survey of the property which documents the location of the artificial berm. The wetland does not about an (a)(1) – (a)(3) water. The wetland is not inundated by flooding from an (a)(1) – (a)(3) water in a typical year. Therefore, the wetland is a non-adjacent wetland and not jurisdictional.
