**C. Additional comments to support AJD:** The unnamed tributary was not flowing during the time of my site visit. From May 9-May 12 approximately 0.90 inches of rain fell in Jonesboro, AR. The channel is shown on the USGS topographic map as a dotted blue line that starts approximately 1,000 linear feet to the west. This area has experienced major industrial development and the channel approximately 1,000 linear feet to the west is no longer present.
