and within the 30 year normal range. The finding based on this assessment is that the time period under review was typical.

C. Additional comments to support AJD: Google Earth shows Hindman Creek flowing in February of 2020, March of 2017, January of 2016, May of 2015, February of 2014, and April of 2012. The APT tool determined that the time period under review for each date listed, with the exception of February or 2020, was 'normal' or 'drier than normal' and within the 30 year normal range. This shows that Hindman Creek flows during 'normal' and 'drier than normal' conditions.
