The feature flows only in direct response to rain events. The feature lacks the presence of an ordinary high-water mark (OHWM). And after a desktop review it was noted the feature does not appear as a solid or dashed blue line on topographic maps.

**B. Typical year assessment(s):** [The antecedent precipitation tool was run for the day of the USACE site visit and the results were “wetter than normal” finding. This supports the ephemeral nature of the feature due to the lack of flow being present on April 26, 2021 during a wetter than normal period of time.](#)


<sup>5</sup> Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

**C. Additional comments to support AJD:** The agent provided the following explanation of site conditions, “The drainage channel is piped upgradient of the site. The channel daylights on the property through culverts located in the northwestern portion of the site. Overall, geomorphological development within the channel is weak. Moss was growing within the upgradient end of the channel. It did not appear that the channel regularly carries flowing water. Although it is obviously that water is carried by the channel it is likely only after rain events. Ordinary high water indicators in the channel were weak. During the site visit of April 26, 2021, flowing water was not present in the channel even though this season has had abnormally wet weather conditions. According to StreamStats, the drainage area of the channel is only 0.13 square miles or 83.2 acres at its downgradient end.”
