It retains wetland characteristics but is not adjacent to a jurisdictional water, does not maintain a visible surface connection to a jurisdictional water, nor is it within the flood zone of a jurisdictional water in a typical year.		
Ephemeral 1	1823	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	Ephemeral 1 is a channel has been extensively graded along the north portion of the site and is primarily a shallow swale with no substantial stream morphology. As overland flow from the agricultural field concentrates in the middle portion of the site, the channel becomes more erosional, creating a significantly incised (6+ feet deep, 2-3' wide) U-bottom channel without a defined bed/bank demarcation and no evidence of consistent flow, such as sediment sorting, depositional features, or indicators of an ordinary high-water mark. There was no water in the channel during the site reconnaissance, no evidence of subsurface discharge into the channel, and the hyporheic zone was dry.		
Ephemeral 2	444	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	Ephemeral 2 is a small ephemeral dug ditch acting as a tributary to Ephemeral 1. Ephemeral 2 appears to be a dug and erosional feature, being incised with a V-shaped bottom and lacking an ordinary high-water mark.		
Ephemeral 3	660	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	Ephemeral 3 is a small ephemeral ditch acting as a tributary to Ephemeral 1. Ephemeral 3 appears to be an erosional feature, being incised on its lower reach with a U-shaped bottom and lacking an ordinary high-water mark.		
Ephemeral 4	186	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	Ephemeral 4 is an erosional feature in an upland agricultural field that temporarily channels overland flow before releasing the flow back overland into a wooded area. The ditch lacks an ordinary high-water mark.

The ditch lacks an ordinary high-water mark and is partially vegetated with upland grasses.
