- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Three potential waters were identified on the eastern portion of a 27-acre parcel of property by SWCA Environmental Consultants during a field survey on February 15, 2022. SWCA documented their findings in a delineation report, dated March 2022. WCA001 and WCA002 lack ordinary high water mark indicators and are therefore not considered Waters of the United States. Both WCA001 and WCA002 no longer contribute or receive hydrology from Fletcher Creek which is located just north of the property as evidenced during the Corps' site visit on**

April 27, 2022. WA001 is a 0.23-acre wetland that has formed within the far eastern end of feature WCA001. It was observed during the April 17, 2022 site visit that no swales or other drainage features are present that would hydrologically connect WA001 to downstream waters. Fletcher Creek is deeply incised with OHWM approximately 35 feet below the top bank and does not serve as a source of hydrology to adjacent land. The subject feature is functioning as a depressional wetland that receives solely overland flow and direct precipitation. The Corps has concluded the feature identified by SWCA as WA001 (0.23-acre) is an isolated water, and not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a)..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
