Both of these features were determined to be erosional ditches that lack the presence of an ordinary high water mark as stipulated in RGL 05-05.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Site visits have indicated that biological/physical characteristics are limited to deposits of leaf litter and minor occurrences of drift debris along the banks which indicate brief, low volume flows during precipitation events. Each of the streams and their adjacent wetlands are a distance of approximately 16 river miles from the nearest TNW (Hatchie River). The streams estimated frequency and duration of flow of 11-20 events indicates that it does not have substantial capacity to transfer nutrients and organic carbon vital to support food webs given the weak biology indicators associated with these features, their distant proximity to the nearest TNW, and their overall low volume (approx. 5,000 CF or less). Additionally, the upper prongs of Muddy Creek, which is a receiving water, are listed on the Mississippi DEQ 303(d) list of impaired streams. Impaired uses are aquatic life support. The relative contribution of each of the streams including their adjacent wetlands with respect to functional capabilities including sediment trapping, retention, and transport; pollutant trapping, filtration, or transformation; nutrient recycling; export of organic matter; export of food resources; and provision of life cycles dependent on aquatic habitat relative to the length and functional capacities of downstream RPWs, would not contribute to the chemical, biological or physical integrity of the Hatchie River (nearest TNW) in such a manner that is more than speculative in nature.

The storm water is conveyed downgradient through the subject property's drainage area, where storm water runoff is compounded with groundwater flows that are carried through the intermittent streams. The intermittent streams will convey seasonal flows throughout the typical year to the southeast off the subject property.
