C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

acre wetland depression adjacent to P1. The grouping of W-2, W-3, W-6, and Pond 1 is surrounded entirely by upland fields, and Pond 1 is not an impoundment of other waters of the U.S.

Wetland 4 (W4) is an approximately 0.64-acre depressional wetland that developed from the shallow remnants of Pond-2. The grouping of Pond 2 and W4 is hydrologically isolated and surrounded entirely by upland farm field.

Wetland 5 (W5) is an approximately 0.04-acre depressional wetland that developed along a fence line and is surrounded entirely by upland farm fields and is therefore hydrologically isolated.

Wetland 8 (W8) is an approximately 0.25-acre wetland located in a farm field that was previously confirmed by the USACE August 12, 2022 and is hydrologically isolated. The surrounding upland areas did not have hydric soils or hydrophytic vegetation and evidence of sheet flow from this area was not observed.

Per the preamble to the 1986 regulations Ponds 1 and 2 are not considered waters of the United States. These farm ponds were constructed in uplands and it appears that the wetlands 2, 3, 4, and 6 (described below) either formed from the remnants of portions of the ponds or in response to berms created from the construction of the ponds.

Wetlands W2, W3, W4, W5, and W8 are surrounded by uplands, do not drain directly or indirectly to any waters of the United States, and do not support a link to interstate or foreign commerce: they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
