### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Feature D-2 has sufficient flow to maintain strong bed and bank

features as well as develop riffle-pool sequences, depositional bars, and sediment sorting. The report notes that Feature D-3 had weak subsurface flow, indicating a groundwater connection, isolated pools within the channel that supported amphibians, as well as sufficient flow to allow development of point bars and riffle-pool sequences within the subject reach. Both D-2 and D-3 are within an area mapped as having Falaya Silt Loam soils (with some hydric Waverly Silt Loam inclusions); Falaya Silt Loam has a seasonal water table (April through June) of 46 cm from the surface; these channels are 7 and 12 feet deep, indicating a groundwater connection that would support seasonal flow.

Corps of Engineers regulations (33 CFR 328, published in the Federal Register Volume 51, Number 219, on November 13, 1986) states "for clarification, it should be noted that we generally do not consider the following waters to be "Waters of the United States"...(c) artificial lakes and ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing..." Accordingly, these features are considered to be non-jurisdictional features excavated in dry land and not jurisdictional impoundments.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
