Explain: **WWC1 begins downgradient from an overflow channel for P1 and flows for 452 feet before entering an unnamed RPW. The channel lacks an ordinary high water mark at the outfall of P1 but indicators of an OHWM are present at the downstream end. W2 is a .025-acre wetland that flows through WWC4, an upland drainage (erosional) feature, into P1, a pond created in uplands, and then into WWC1 before entering an unnamed RPW.**

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Summarize overall biological, chemical and physical functions being performed: The subject wetland retains some runoff from surrounding open fields and likely provides some habitat for amphibians and aquatic invertebrates.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Non-RPW WWC1 has only one adjacent wetland (a small depressional feature at the upstream end of an erosional gully). Water leaving the wetland would flow through the erosional feature before entering a pond and a non-jurisdictional overflow swale before entering the subject non-RPW. Combined, these features flow into an unnamed relatively permanent tributary before flowing into Nonconnah Creek and continuing into the Mississippi River. Nonconnah Creek is listed on the most recent 303(d) list for Tennessee as being impaired for, among other factors, nutrients, bacteria, physical substrate alteration, sedimentation/siltation, and dissolved oxygen. Considering the relative infrequent number of estimated flow events, the small volume of water contributed to downstream reaches, the added function of the pond in retaining runoff beyond that stored in the subject wetland, and the level of impairment within the approximately 17-mile reach of Nonconnah Creek between McKellar Lake and the subject property, WWC1 and its adjacent wetland do not contribute to the chemical, biological, or physical integrity of the nearest TNW in such a manner that is more than speculative in nature. Therefore, the Memphis District has determined that these features are not considered jurisdictional Waters of the United States.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
