Explain: **The subject property contains an approximately 0.29-acre scrub-shrub wetland. This wetland is located approximately 2,300 feet from the nearest stream channel (Johns Creek) and is surrounded on all sides by uplands, including industrial developments and a large railroad yard. The wetland is not located within the 100-year floodplain and lacks any visible surface connection to downstream waters. Furthermore, the wetland does not support any known links to interstate or foreign commerce, including recreational use, fish/shellfish production, or industrial use.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
