Explain: **There are approximately 1.72 acres of isolated wetlands within a 100-acre parcel of property boundary. The subject parcel is located northwest of Walnut Grove Road and North Houston Levee Road in Shelby County, TN. Both wetlands, labeled Wetland 3 and Wetland 4, are located on the eastern portion of the property and are 0.96-acre**

and 0.76-acre in size, respectively. The wetland delineation was conducted by the agent on September 17, 2021 and the results were provided in a report, dated March 30, 2022. Both Wetland 3 and Wetland 4 are palustrine, emergent, persistent, and seasonally flooded/saturated wetlands (Cowardin code PEM1E). As evidenced in the field by the agent and a review of available Google Earth aerials, both wetlands occur in slight, closed depressions with no apparent surficial or shallow-subsurface hydrological connection to downstream waters. As shown on the FEMA Flood Insurance Rate Map, these wetlands are not within the floodway and do not occur within a flood hazard zone. The Corps has concluded the features identified as Wetland 3 and Wetland 4 are isolated, and not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Explain: **An on-site field visit was conducted by the agent on June 24, 2021, December 2, 2021, and March 2, 2022 of a 100-acre parcel of property northwest of the Walnut Grove and Houston Levee Road intersection in Shelby County, Tennessee. During the field visit, a potentially jurisdictional watercourse was identified on the site. This watercourse**

is located at coordinates N35.132071, W89.732753 and runs in a northeast to southwest direction for a length of 395 linear feet near the central portion of the site. The watercourse is essentially straight and was observed by EnSafe as an erosional ditch previously constructed in uplands and does not replace a naturally occurring tributary. The Corps has reviewed EnSafe's report and has determined that the watercourse is present due solely to erosional processes resulting from adjacent overland flows and is, therefore, not considered a jurisdictional waters of the United States.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
