Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The subject property is a 31.63-acre site in Collierville, Shelby County, Tennessee. The land owner's consultant, Brophy-Heineke & Associates, completed a wetland and other waters delineation on this site on July 23, 2021. The results of which are available in the associated Water Resource Delineation Report prepared for the Tennessee Department of Environment and Conservation. This wetland (Wetland 1) was identified by the consultant

in the north-central portion of the site at N35.024667°/W89.678275° as shown on the associated Features Map. The wetland is surrounded by upland habitat and is located within a shallow depressional area that lacks any outlet channels, swales or other drainage features that would provide a hydrologic connection to waters of the US. There are no non-RPWs or RPWs of the U.S. within the 0.16 square mile watershed in which this wetland is found. The wetland is not within the FEMA 100 year floodplain. The wetland is dominated by young black willow trees and herbaceous hydrophytic vegetation and provides only minimal wetland functions. The wetland does not support any known links to interstate or foreign commerce, including recreational use, fish/shellfish production, or industrial use. Because this wetland is hydrologically isolated lacking any surface hydrological connection to a TNW, it does not meet the criteria of a waters of the US and is therefore not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

# B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
