Explain: **C6-EPH is an 105 linear foot non-jurisdictional ephemeral channel. The channel begins as an upland drainage feature that lacks indicators of an ordinary high water mark before forming a distinct channel for 105 feet.**

However, C6-EPH terminates into Wetland 2 (WTLD 2) which is a 0.53-acre depressional wetland. No defined channels leave WTLD 2; therefore, this feature (and C6-EPH) are considered isolated as they lack an observed surface

connection to downstream waters. Furthermore, WTLD 2 does not support a link to interstate or foreign commerce (including recreation and fish/shellfish production), and is not known to be used for industrial purposes that could affect interstate commerce. Therefore, WTLD 2 is not considered jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Immediately upstream of the subject ephemeral stream the channel is a small erosional feature that lacks an ordinary high water mark (C6-UD). The subject channel eventually flows into WTLD 1, which is a wooded wetland. Although C6-EPH supports the hydrology of WTLD 1, the volume of water is insufficient to establish a distinct surface connection between Flippin Creek and also into the Obion River. Considering the relatively infrequent number of estimated flow events, an estimated volume of 420 cubic feet, a distance of over 80 miles to the nearest TNW, and input from the impacted downstream reaches, C6-EPH does not contribute to the chemical, biological, or physical integrity of the nearest TNW (the Mississippi River) in such a manner that is more than speculative in nature .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
