PUBLIC NOTICE FOR FEDERAL REGISTER NOTICE ANNOUNCING THE REISSUANCE OF THE NATIONWIDE PERMITS

On December 27, 2021, the U.S. Army Corps of Engineers (Corps) published a final rule in the *Federal Register* (86 FR 73522) announcing the reissuance of 40 existing nationwide permits (NWP) and one new NWP. These 41 NWP will go into effect on February 25, 2022, and they will expire on March 14, 2026:

- NWP 1 – Aids to Navigation
- NWP 2 – Structures in Artificial Canals
- NWP 3 – Maintenance
- NWP 4 – Fish and Wildlife Harvesting, Enhancement, and Attraction Devices and Activities
- NWP 5 – Scientific Measurement Devices
- NWP 6 – Survey Activities
- NWP 7 – Outfall Structures and Associated Intake Structures
- NWP 8 – Oil and Gas Structures on the Outer Continental Shelf
- NWP 9 – Structures in Fleeting and Anchorage Areas
- NWP 10 – Mooring Buoys
- NWP 11 – Temporary Recreational Structures
- NWP 13 – Bank Stabilization
- NWP 14 – Linear Transportation Projects
- NWP 15 – U.S. Coast Guard Approved Bridges
- NWP 16 – Return Water from Upland Contained Disposal Areas
- NWP 17 – Hydropower Projects
- NWP 18 – Minor Discharges
- NWP 19 – Minor Dredging

- NWP 20 – Response Operations for Oil or Hazardous Substances
- NWP 22 – Removal of Vessels

The new NWP 59 authorizes discharges of dredged or fill material into waters of the United States for the construction, expansion, and maintenance of water reclamation and reuse facilities.

The Corps has also issued final decision documents for these new and reissued NWPs. These final decision documents are available at www.regulations.gov at docket number COE-2020-0002.

The 40 existing NWPs published in the December 27, 2021, final rule replace the 2017 versions of these NWPs. The 2017 versions of NWPs 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17, 18, 19, 20, 22, 23, 24, 25, 27, 28, 30, 31, 32, 33, 34, 35, 36, 37, 38, 41, 45, 46, 49, 53, and 54 expire on February 24, 2022.

The NWP general conditions and definitions that were issued in the final rule that was published in the January 13, 2021, issue of the *Federal Register* (86 FR 2744) apply to the 40 reissued NWPs and the new NWP 59 that were published in the *Federal Register* on December 27, 2021.

With the publication of this *Federal Register* notice, Corps divisions finalized regional conditions for these 41 NWP's. Division Engineers prepared supplemental documentation to address decisions concerning the consideration of regional conditions for the 41 NWP's. The Corps divisions servicing the State of Mississippi have determined that, given the conditions of water quality certifications and Coastal Zone Management Act consistency certifications, no regional conditions are necessary, and that, without additional regional conditions, the implementing districts will ensure that the NWP's authorize only those activities that have no more than minimal adverse environmental effects.

Corps divisions and districts determined which conditions for water quality certifications issued by states, tribes, and EPA for the issuance of these 41 NWP's become regional conditions of these NWP's. Corps divisions and districts also determined which conditions for Coastal Zone Management Act consistency concurrences issued by states for the issuance of these 41 NWP's become regional conditions of these NWP's. Water quality certification and Coastal Zone Management Act consistency regional conditions will be announced in a future public notice issued by the Vicksburg District.
